# **INTAKE**

**FOR HOUSING AND SERVICES**

Thank you for your interest in Porchlight, Inc. Porchlight operates multiple housing units ranging from single room occupancy (SRO) units to family units with 2-4 bedrooms. The units are leased on a month-to-month basis. The programs we offer and the rules for maintaining housing differ from site to site. One of Porchlight's purposes, in addition to providing low-cost housing, is to provide opportunities for residents to participate in life skills training programs. All programs require participation in these services. **Income must equal two times the amount of rent.** These programs are described below.

**Sober Living**

Permanent one-bedroom units for men and women in recovery from alcohol and drug abuse (90 days of sobriety required). Case management services are provided and may include money management, personal health, relapse prevention, parenting, assistance with permanent housing and employment counseling. **Rents start at \$500 per month.**

**Single Individual Housing**

Permanent housing program, single room occupancy units for men. Shared kitchen and bathrooms. Case management services are provided and may include money management, personal health, parenting, assistance with permanent housing and employment counseling. **Rents start at \$350 per month.**

**Family Housing**

Apartments ranging from 2-4 bedrooms, transitional (24 months) and permanent units. Case management services are provided and may include money management, personal health, parenting, assistance with permanent housing and employment counseling. **Rents range from \$650 to \$900 per month.**

**Brooks Street**

Permanent single room occupancy units for low-income men and women. Shared kitchen and bathrooms. Case management services may be provided and can include money management, personal health and individual living skills. **Rents range from \$245 to \$435 per month.**

**Veteran's Housing Program**

*Transitional* single room occupancy units for homeless persons who have served in the U.S. military and have honorable discharges. Shared kitchen and bathrooms. Sober living environment with case management services provided. (Must provide DD214 form). Must be currently homeless to qualify. **Rent is 30% of income.**
